Hon'ble Supreme Court of India in the aforesaid order has directed that "the NEERI and PESO to stick to the aforesaid timelines given in these minutes (dated 27.02.2019 by NEERI). In this regard the Deputy Chief Controller of Explosives Sivakasi and other respective Circle Heads shall receive all the application submitted by Fireworks manufacturers and shall ensure that the manufacturers had obtained certificate from NEERI or any NABL accredited laboratories for maintaining the emission standards with respect to the chemical composition submitted by them for approval.

An in principle approval shall be accorded to the manufacturers within 5 days of receipt of the application enabling them to start the production and may forward the final recommendation to Chief Controller of Explosives along with certificates from NEERI or any NABL accredited laboratories for maintaining the emission standard or/and after conducting all the necessary tests as prescribed in Rule 6 of the Explosives Rules 2008 for Authorization by CCE as required under Rule 6(1) of the aforesaid Rules within 30 days.
